


# REPRESENTATIVE COUNCIL MEETING:

### **SABEA Elections:**

This is the year that we elect our executive board and delegates to the NYSUT Representative Assembly. The officers of this organization shall be: President, Executive Vice President, First Vice President-Faculty Grievance Chair, Second Vice President-SRP Grievance Chair, Treasurer, Secretary, Membership Chair, and Labor Ambassador. Nominations Chair Chris Ogden will be gathering nominees for our June elections. If you would like to see the duties of these positions, ask your rep for a copy of the SABEA Constitution. Nominations will close in May for elections in June.

#### TCI:

A mentioned earlier this year, staff who are required to participate in TCI training and refreshers receive a letter that they may need to have their medical professional complete regarding their ability to do physical restraints. As in the previous newsletter you are advised to cross off the middle section that would release all of your records to the BOCES. You are not required to give them that access.

In order to have the body portion of the form completed, if you have been or under the care of a medical professional, you should not have to have an appointment to see them in order to have the form filled out. Just fax, mail or drop off the form and let them know when you need it back. The majority will be able to do this- no copays involved. You may want to let them know that you will need this completed twice a year so they might want to keep in your file and just update as you contact them.



# **Personal Business Days:**

Please make sure that you read our contracts regarding Personal Business Leave. This is article 6.3 (Faculty) and 6.4 (SRP). Personal Business is intended for business matters that cannot be transacted outside school hours/working hours.

Unit members NEED NOT give a reason but merely indicate that the request complies with the above definitions. Requests shall be submitted to immediate supervisor, in writing, at least 24 hours prior to date requested. It then will go through the regular process for approval. Except for an emergency, not to exceed one day per year. Personal business leave generally shall not be used to extend a recess or holiday period.

Contact your building rep if you have questions regarding this contract benefit.


# Committee of 100

**Beyond Bias:** A dynamic multi-media presentation framing a thought provoking examination of the ways overt and covert media bias warp perceptions of women, people of color and the LGBTQ community...and how we as unionists and educators, can and must counter bias wherever it occurs.

**Start the Conversation:** A discussion about racial diversity, equality and tolerance at school, on campus, and in the community. Why? Because there's no better time; lives matter; bigotry cannot prevail; opportunity should be equal for all; and truth triumphs over false ideas.

Retirement (In) Security: Preparing for the golden years in the age of uncertainty. This is not your parents' retirement. #### **BOCES LOBBY DAY- March 1**

On March 1, BOCES unions from around the state came to Albany to speak to our representatives regarding issues that would assist us in serving our populations. We met with Assembly people and Senators from our region.

## Issues brought up included:

- A bill that would increase the aidable salary for BOCES CTE programs. The current aid formula has not changed since 1990 so the state only provides aid for the first \$30,000 of a BOCES instructor's salary;
- a bill that would allow BOCES to establish reserve funds to cover long-term costs;
- a bill that would provide BOCES building aid for school safety expenses like metal detectors and security devices;
- a bill that would provide preschool special education programs with a desperately needed cost-of-living adjustment; and
- A bill that would exempt BOCES capital projects from the property tax cap.

# **Food for Thought: Deviled Eggs**

#### Ingredients

- 6 hard-cooked eggs
- 2 tablespoons mayonnaise
- 1 teaspoon white sugar
- 1 teaspoon white vinegar
- 1 teaspoon prepared mustard
- 1/2 teaspoon salt
- 1 tablespoon finely chopped onion
- 1 tablespoon finely chopped celery
- 1 pinch paprika, or to taste




#### Directions

 Slice eggs in half lengthwise and remove yolks; set whites aside. Mash yolks with a fork in a small bowl. Stir in mayonnaise, sugar, vinegar, mustard, salt, onion, and celery; mix well. Stuff or pipe egg yolk mixture into egg whites. Sprinkle with paprika. Refrigerate until serving.

# Simplifying your life insurance options

As an educated consumer, you realize the earlier in life that you purchase life insurance, the cheaper the premiums will likely be. You're also aware that life insurance offers financial protection for your dependents upon your death, helping to cover the costs of funeral and burial expenses; assistance to help with your children's education; and offering financial assistance with paying debts and other expenses.

It can be overwhelming, though, trying to determine the best type of life insurance policy. Let's take a look at some of the different types of life insurance options available.

#### #1: Whole Life Insurance

- This type of insurance is usually the most costly since policies are guaranteed to remain in force as long as premiums are paid. Whole life insurance offers permanent protection with premiums that never increase and builds cash

value you can borrow against while you are living (like a loan). Important: Understand that you will reduce your death benefit if you don't repay loans with interest and will no longer have coverage if you surrender the policy.

#2: Term Life Insurance – This type of insurance pays a benefit in the event of the death of the insured during a specified term, offering a fixed rate of payments during that time period. Once that period ends, coverage at the previous premium rate is not guaranteed and the insured would need to get further coverage. Term life insurance (and its level term life cousin) is designed only to protect your dependents if you were to die prematurely -offering NO cash value.

#3: Level Term Life Insurance - Like term life insurance, level term life insurance pays a benefit in the event of the death of the insured during a specific time period. Premiums may not be

increased during the time

period due to change in your age or health status.

#4: Universal Life Insurance - This type of insurance offers a way to protect your dependents while building tax-deferred cash value. While the cost of a universal life plan needs to be covered so the policy remains in force, the policyholder has the option to adjust how much he or she will pay in premiums each year. Policyholders can also access a portion of the balance without affecting the

guaranteed death benefit as the cash value accumulates over time.

Keep in mind that NYSUT members & their spouses/certified domestic partners can help protect their dependents from life's uncertainties with a variety of NYSUT Member Benefits-endorsed life insurance plans. Many of these plans offer group rates not available to the general public along with additional convenience and savings opportunities.
