As an employee, you may have a right to the presence and counsel of a union representative at a meeting where your conduct is being questioned and you reasonably believe disciplinary action may result. If you are in doubt about whether you are entitled to union representation, ask for it anyway.

Contact Kelly Dowd for more information on how to contribute or to increase your contribution! Why contribute to vote cope? VOTE-COPE is NYSUT's non-partisan action fund that coordinates the voluntary contributions of members and supports NYSUT-endorsed candidates and campaign committees that are pro-public-education and pro-labor.

No NYSUT dues dollars are used to support candidates or campaign committees.

NYSUT sends rebates to local unions based on a percentage (up to 40 percent) of the contributions VOTE-COPE receives from that local union's members. Those rebates can be used in local activities such as school board races and for passage of school budgets.

~ALBANY, N.Y. March 8, 2016 — More than 800 New York State United Teachers' activists converged on the state Capitol today to urge lawmakers to take advantage of the state's \$5.4 billion budget surplus and make significant new investments in public education.

NYSUT President Karen E. Magee said the union's volunteer lobbyists would press legislators to boost state aid to public schools by \$2.5 billion and make good on \$318 million in prior year aid claims, while advocating that elected leaders enact a true maintenance of effort bill and help CUNY and SUNY recover from the loss of \$1.5 billion in state support since 2008.

~ Bernard Washington, a member of the Syracuse Teachers Association, rose to his feet to address new Assembly member Pamela Hunter, D-Syracuse, about a \$15 minimum wage.

~ The National Education Association, one of NYSUT's national affiliates, is spreading more than just jam on toast. It's also spreading the news about the benefits of breakfast in the classroom, along with providing resources on how to sign up for programs and explaining how they make a difference.

Starting the day with food calms hunger pains and improves focus. It can improve mental health. Certainly, it can quiet rumbling bellies.

## SRP Leadership Conference

On February 27-28 a SRP's from around the state come together, at the beautiful Otesaga in Cooperstown, to enjoy several different workshops. One which sticks out in my mind the most is "School Violence – Impacts on Staff". This was an eye opening experience for many. Things that were discussed ranged from, codes of conduct to school safety plans. One of the topics discussed was:

<u>Teacher Authority/ Principal Authority</u> "Allows teachers to remove disruptive pupils from the classroom, consistent with district codes of conduct, with appropriate procedural safeguards for affective students".

#### Disruptive pupil is defined as one who:

• Is substantially disruptive of the educational process or interferes with the teacher's authority over the classroom

#### Violent pupil is defined as one who:

- Commits an act of violence on a teacher, other school district employee, or fellow student
- Possesses, displays, or threatens to use a gun, knife, or other dangerous weapon.
- Knowingly and intentionally destroys the personal property of a teacher or other school district employee.
- Knowingly and intentionally destroys school district property

#### Removal procedures:

- Teachers report and refer violent pupil to administration for minimum suspension period.
- Administration has authority to suspend for up to five days without delegation from board of education.
- District shall implement policies and procedures to provide for continued educational programming for removed pupil.
- Student must be informed of reason for removal by teacher.
- Principal must be informed of reason for student removal by teacher.
- Sets time lines for negotiations of removal to student and parent.
- Requires notification of charges and an explanation for suspension with timelines as required by legislation.
