Food for Thought: Cream Corn

- 2 (10 oz.) packages frozen corn kernels, thawed

Directions


- ✓ In a skillet over medium heat, combine the corn, cream, salt, sugar, pepper and butter.

Our SRP unit recognizes the importance of contributing to this separate organization to influence policy makers on what is important to us as union members and those who work in an educational environment.

<u>School-Related Professionals Recognition Day</u>, celebrated this year on Tuesday, Nov. 15, recognizes the importance of the NYSUT members who are an integral part of students' educational experience.

SRPs are cafeteria workers, custodians, building and grounds workers, clerical staff, bus drivers, monitors and attendants, mechanics, teacher aides and teaching assistants, health care professionals, security personnel and many other members.

ALERT

All members!!!!!! SABEA representatives and executive board has found out from members that some have been called into meetings and not been informed that the meeting is disciplinary. You are, *by labor law*, entitled to have union representation with you. If you are in a meeting and begin to feel that it is becoming a meeting where it will be turn disciplinary, use the following:

Please use this information below when asked to meet with a supervisor:

"If this meeting is in any way related to my work performance or attendance, then I respectfully request that a SABEA Representative be present. Please schedule this meeting at a date and time when my SABEA Representative can be available."

Then, call Ruth (321-8676) for assistance in obtaining the appropriate representation. The SABEA President should be informed prior to such a meeting by the BOCES to follow labor law. We select, not administration, who the representative will be in those meetings.

This does not mean that you can't meet with a supervisor by yourself BUT, know that you are entitled to have a representative with you in disciplinary situations. The ONLY way that our organization, SABEA, knows that you have been asked if you want a representative is for request for representation to go through Ruth. Otherwise, there is no proof that the law is being followed.

- -legal letters written & phone calls made on your behalf (ever been in a situation that you "just needed your lawyer to write a letter?"

-discounts on personal injury cases -document preparation at fixed rate

Members interested in completing their *will*, *power of attorney (POA)*, *health care proxy or living will* need to complete the questionnaire and mail to the law office listed above or make an appointment at one of the two will days in December.
