I was able to attend the Capital District Regional Office Leadership Conference October 13-15. I attended workshops on advancing advocacy in our changing environment to learn how to make the most of provisions in our collective bargaining agreement to strengthen our associations ability to communicate and better represent members. I also attended a session on Family Medical Leave Act and the new Paid Family Leave Act that SABEA will be meeting with the BOCES about in the near future. Another workshop focused on regional trends and topics related to health insurance including prescription formulary design, specialty drugs, health plan design trends and the impact of regional health insurance consortia on negotiations.

The Commissioner of Education invited me to be one of about 20 educators from across the state to be on an advisory council for the next 3 years. I spend the day October 11 meeting

with the Commissioner and her suupport staff from State Education department engaged in meaningful conversations about the Next Generation Learning Standards, APPR, the teacher shortage and the NYS English as a Second Language Achievement Test.

If you are a teacher working on a Students With Disabilities certificate, please consider graduate classes offered through NYSUT's Education Learning Trust. Classes are offered through Empire State College at a significant discount to NYSUT members. AFT-endorsed candidates won big on election night

The Nov. 7 election results were a clear and overwhelming rebuke of the fearmongering and race-baiting that embodies Trumpism, AFT President Randi Weingarten says. "It was also clear that voters understood that running as a populist is not the same as acting as one or governing for the people.

"This election was a real 'which-side-are-you-on?' moment in which the candidates who demonstrated that they truly care for and will fight for people, and that they stand for public education, affordable healthcare and good jobs, overwhelmingly beat those who, like Trump, seek to campaign as a populist but serve the elites."

The results were made possible by the hard work, on the ground, of union members, volunteers and candidates who talked and connected with voters, understood and listened to their legitimate anger and frustration with what is going on in our country today, and offered a path forward based on the aspirations we all share for a better life," she adds.

"Yesterday's results were a clear repudiation of the efforts by Trump and the GOP to strip healthcare away from people, go after people's rights, and push Education Secretary Betsy DeVos' agenda to defund and privatize public schools. And the message to Congress should be clear—don't try to ram through a tax plan that gives massive tax breaks to the rich and

corporations at the expense of the middle class.

"We celebrate every one of our members and every other volunteer who made phone calls, knocked on doors, drove people to the polls, and got out the vote to create a wave of wins across the nation. Elections matter—and we need to continue this wave and this enthusiasm through 2018 to elect even more governors, state legislators, U.S. representatives and U.S. senators who will stand with working folks and not those trying to get even richer off the backs of working families and the middle class."

Highlights from Election 2017:

In Virginia, AFT-endorsed candidates won all statewide elections, and Democrats gained at least 16 House of Delegates seats. The stakes of this election were enormous for working folks and for our kids—and for public education, decency and an economy that works for all.

In New Jersey, AFT-endorsed candidate Phil Murphy won the governor's race by 13 points, and state Sen. Steve Sweeney was overwhelmingly re-elected. These victories offer new hope and new opportunity for the people of New Jersey who for years have had a blustering bully for a governor, who disrespected educators, nurses and working people.

In New York, a referendum calling for a state constitutional convention was defeated with more than 80 percent of the vote. It was the work of union members and allies across the state that helped educate the public and ensure victory on Election Day, despite support for the referendum early in the campaign. And in New York City, Mayor Bill de Blasio was re-elected, becoming the first Democratic mayor to be re-elected there since Ed Koch was re-elected in 1985.

In Douglas County, Colo., AFT members and voters defeated Koch brother-supported, anti-public education candidates to ensure a pro-public education school board.

In Houston, AFT members and voters elected additional pro-public education school board members, who will work with educators and families to help them continue to heal and rebuild after Hurricane Harvey, create community schools, ensure local control and fight for additional funding.

- In Maine, voters approved Medicaid expansion.
- In Washington state, Democrats regained control of the state Senate.
- School bond initiatives won across the country, including in Cincinnati, Austin and across Minnesota.
- The Republican supermajority in the Georgia Senate was broken.
- AFT-endorsed mayors won in Lawrence, Mass.; Detroit; St. Paul, Minn.; and across the country.
- AFT members were elected in Connecticut, New York and Pennsylvania and Virginia.

WE DID IT! NYSUT and coalition partners defeat Prop 1



"On Nov. 7, New York saw what happens when labor organizes, mobilizes and acts as one to protect working people," said President Andy Pallotta.

The overwhelming defeat of the referendum on a constitutional convention -- 83 percent to 17 percent -- was a victory for labor and working people over political insiders and corruption. Two years ago, polling showed two-thirds of likely voters supported the ConCon, and grassroots efforts more than flipped it.

"This is a defining moment for the labor movement as it demonstrates what can be accomplished when we all work together," said state AFL-CIO President Mario Cilento.

Republicans in Congress want to take away your tax deductions

One of the ways President Trump and the GOP leadership are planning to pay for tax giveaways to the wealthiest Americans is by eliminating the state and local tax deduction, which would hurt schools and property values. They also plan to eliminate the teacher deduction for classroom expenses -- \$250 taken from every teacher in New York State.

What do you think about when your hear the term "union work?"



Most people immediately have a vision of unions negotiating contracts that include better pay and working conditions for their members. A sub-set will think about union members picketing or protesting an injustice -- or even going on strike -- to defend bedrock principles. And, sure, unions like NYSUT regularly fight for better healthcare, safe working conditions and an affordable college education for all. We raise money for victims of national tragedies, like the recent hurricanes that hit Texas, Florida, Puerto Rico and the Virgin Islands. Yes, union work involves all of that. It's in our DNA. But, union work can also mean organizing an entire region's population to come together to strengthen education and bring jobs back. That's exactly what is happening now in an impoverished corner of the North Country. The People Project in Saint Lawrence County is an exciting new, union-led initiative that is expanding the definition of "union work." The People Project has its origins in the successful 2015 effort to stop ALCOA - the giant aluminum manufacturing company - from fleeing Massena and taking with it hundreds of good-paying union jobs. Once the union-

led coalition succeeded in keeping those ALCOA jobs in the North Country, it became apparent that there is still a lot of work to do in Saint Lawrence County. Led by NYSUT member Erin Covell – and armed with grant money and support from NYSUT and the American Federation of Teachers – the People Project is now on to Phase Two. It has brought together local educators from all 18 St. Lawrence County school districts. They are working to build a vibrant network that focuses on community engagement; high-quality public schools; and a sustainable economy that supports everyone.

For the past year, The People Project has been working closely with community members, employers, government and not-for-profit leaders to better identify community needs – and to come up with solutions. The coalition has already begun working to strengthen community services such as literacy and education, improve health services, start a healthy foods initiatives, and support affordable housing and mentoring programs. The big idea is, that if children and their communities do better, this growth will better position Saint Lawrence County to attract more good jobs and spark a new cycle of economic development. The seeds are there. Saint Lawrence County is already home to two SUNY campuses, a private college and a number of health and human services organizations. Volunteer fire departments, members of the faith community and local business leaders have all bought in and joined the coalition. The People Project is meeting for its first summit at SUNY Potsdam and I plan on being there.

I think it's great that NYSUT local unions are stretching the definition of union work. It's good for children. It's good for schools. It's good for the community. And, its good for the local economy. And, when 18 local unions are spearheading the effort, there's no doubt the People Project will succeed.
