Addenda: Video/remote teaching impacts:

There was a meeting with BOCES administration regarding the recordings of videos in CTE and ELD classrooms as an add-on to remote instruction. Concerns regarding liability were raised, and discussion included information as follows: -NYS law protects teachers and staff while doing their job.

-BOCES will provide a best practices on how to teach online and hybrid models using the tools we have.

-Administration will discuss evaluations in their cabinet meetings on what to look for during the evaluation process.**
